We would like to inform you about the Socially Useful Productive Work (SUPW) activities for in the **academic session 2026-27**. The SUPW programme offers a wide range of enriching activities aimed at nurturing creativity, teamwork, practical skills, and holistic personal development among students.

To ensure that each child gains maximum benefit from the programme, we endeavour to align SUPW activities with students' interests and aptitudes. In this regard, we request parents to kindly log in to the school ERP and submit their ward's preferred choices for SUPW activities within the stipulated time.

Your cooperation will enable us to plan and design a well-structured schedule that encourages active participation and meaningful learning experiences for all students.

Please note:

1. Each child is eligible to be a part of only one activity in the entire session.
2. Process to fill SUPW Activities Selection Proforma:
 - a. Login to ERP by visiting the student portal at the school website or clicking on the following link: <https://vivekanandschool.in/vksav/studentLogin/login.do>
 - b. Click on the SUPW Preferences appearing on the menu bar of the Home page of the ERP (please refer to the image below):



c. Mention whether Sports activity is to be chosen or not (please refer to the image and table below)

3. **The last date for submission of the SUPW Activities preferences is 11th February, 2026 failing which the school shall allot the SUPW activity at its sole discretion.**
4. The Activity will be allotted as per chosen preference, subject to the availability of the seats (with the exception of a few, where selection is on the basis of trials).
5. Trials for selection for the chosen activity (wherever applicable) will be conducted and the students who have chosen activities having compulsory trials, will have to report for the same. The details of the same will be duly intimated to the students.

6. **Students who fail to report for the trials will not be considered for the chosen activity.** In such cases, the activity shall be allotted based on seat availability and may differ from the student's preferences.
7. Students will be assessed and graded based on their performance, participation, and conduct during each SUPW period. The final grade will be reflected in the student's report card at the end of each term.
8. **Students are advised not to purchase any equipment, kit, or material related to SUPW activities until the final allotment of the activity is officially confirmed by the school.**
9. During the activity days, students must bring their own material/ kit/ resources (wherever applicable) required for the activity, as indicated in the list of the activities.

10. No change in the allotted SUPW activity shall be permitted during the first term. **Any change may be considered only at the commencement of the second term, subject to seat availability.** Migration from sports to non-sports activities may be permitted; however, migration from non-sports activities shall be restricted to non-sports activities only.
11. If a student is found bunking SUPW periods, the matter shall be treated as a discipline violation, and appropriate action, including suspension, shall be taken as per school rules. Upon three such violations, the school reserves the right to change the student's allotted SUPW activity. The decision of the school in this regard shall be final.

We appreciate your cooperation in making the SUPW program a rewarding and enjoyable experience for your child.
